(the receipt whereof is hereby acknowledged) have granted, bargained, sold, and released, and by these presents do grant, bargain, sell and release unto the said City of Greenville, S. C. and County of Greenville, S. C., their successors and assigns:

All that piece, parcel or lot of land in Township, Greenville County, State of South Carolina.

All that piece, parcel or lot of land in Gantt Township, State and County aforesaid, consisting of 2.81 acres and having the following metes and bounds, to-wit:

BEGINNING at a point in the center of the Old Fork Shoals Road on the line of property of the Shockley estate; thence S. 70-15 E. 30.34 feet, more or less, to a fence; thence in a southerly direction along said fence approximately 25 feet east of the center of the Fork Shoals Road to an iron pin approximately 556.79 feet north of Ashmore Bridge Road; thence in a westerly direction to the center of Fork Shoals Road; thence along the center of said Fork Shoals Road in a northerly direction to the beginning corner.

ALSO, all that piece, parcel or lot of land in Gantt Township, State and County aforesaid, containing .16 of an acre and having the following metes and bounds, to-wit:

BEGINNING at a point on a fence 25 feet east of the center of the Fork Shoals Road, running thence along said fence 25 feet east of the center of the Fork Shoals Road S. 22-49 E. 275.54 feet to an iron pin at the corner of said fence; thence S. 67-11 W. 25 feet along said fence to the center of the Fork Shoals Road; thence N. 22-49 W. along the center of Fork Shoals Road 275.54 feet; thence N. 67-11 E. 25 feet to the beginning corner.

ALSO, all that piece, parcel or lot of land in Gantt Township, State and County aforesaid, containing .48 of an acre and having the following metes and bounds, to-wit:

BEGINNING at a point in the center of Ashmore Bridge Road on branch on line of lands now or formerly of W. G. Coxe, running thence N. 41-11 E. 48.94 feet to a fence; thence along said fence N. 41-11 E. 187.04 feet to a point; thence along said fence in a curve to the left 2 degrees, 56 minutes, 19 seconds 218.93 feet to a point; thence along fence N. 34-45 E. 247.35 feet; thence S. 41-11 W. 679.53 feet to the beginning.
