4700 PROVISIONS—JANUARY 20—GREENVILLE

TO ALL WHOM THESE PRESENTS MAY CONCERN:
WHEREAS, R. N. Smith

County Treasurer of said Greenville County, did issue his warrants directed to the Delinquent Tax Collector for said County and State by authority of the acts of the General Assembly of South Carolina and the statute laws of said State, against Ottaray Investment Co., Lakeside Realty Co. Marsmen Inc. & W. D. Workman

defaulting taxpayer(s) of said County, strictly charging and commanding said Delinquent Tax Collector of said County to levy by distress and sale of the lands of the said Ottaray Investment Co., Lakeside Realty Co. & Marsmen Inc. & W. D. Workman tax defaulter(s), the sum of twenty six & 81/100 dollars including the penalties on said tax execution(s) for the year(s) 1927, 1928, 1929, 1933, 1934, 1926 together with charges and costs thereof; and

Whereas, by virtue and authority of said warrants W. A. Hopkins the delinquent tax collector of the State and County aforesaid, did on the 5th day of June 1936 seize and take exclusive possession of the said property against which said taxes were assessed and levied, as hereinafter described, and on Sales Day of the month of July during the usual hours of sale, after due advertisement, sell the same to The Forfeited Land Commission and ~~their assigns~~ or successors assigns/the purchaser(s), hereinafter known as "grantee(s)," and the highest bidder at such sale, for the sum of twenty six & 81/100 dollars and gave a receipt for said purchase money to them; and

WHEREAS, more than twelve months have elapsed since the date of said sale, and the defaulting taxpayer(s), or any other party interested, have failed to redeem said land so sold for taxes;

Together with all and singular the Rights, Members, Hereditaments and Appurences to the said Premises belonging, or in anywise incident or appertaining, To have and to hold all and singular the premises hereby granted, with the appurtenances, unto the said The Forfeited Land Commission their ~~assigns~~ or successors assigns/forever, according to the form in force and effect of the laws and usages of the State of South Carolina in such cases made and provided.
