had only two witnesses and was not recognized in South Carolina, therefore she died intestate
as to the above property; a son Harvey C. Trammell who died intestate in the year 1925, leaving no
children but a widow Ruth Batson Trammell, who subsequently married a Gilreath; and a son B. H.
Trammell, one of the grantors herein.
