Renty Joe Lister, Her Heirs and Assigns:-

All of that certain piece, parcel or lot of land situate, lying and being on the Southeast side of Elizabeth Drive, near the City of Greenville, County of Greenville, State of South Carolina, in the Subdivision known as North Sunset Hills, and being shown as Lot No. 32 on a plat of said subdivision made by Dalton & Neves, Engineers, July, 1941, and recorded in the R. M. C. Office for Greenville County in Plat Book L, at page 92, and having, according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southeast side of Elizabeth Drive, joint front corner of lots No. 31 and 32, and running thence with the Southeast side of Elizabeth Drive, S. 53-14 W. 64 feet to an iron pin, joint front corner of lots No. 32 and 33; thence with the common line of lots No. 32 and 33, S. 37-14 E. 157.3 feet to an iron pin on the Northwest edge of a five foot strip reserved for utilities; thence with the Northwest edge of said reserved strip N. 50-52 E. 63 feet to an iron pin on the Northwest edge of said reserved strip, joint rear corner of lots No. 31, and 32; thence with the common line of lots No. 31 and 32 N. 36-53 W. 154.4 feet to an iron pin on the Southeast side of Elizabeth Drive, the beginning corner.

This is a part of the land conveyed by Riverside Land Company to Knox L. Haynsworth, as Trustee, by deed dated June 9, 1941, and recorded in the R. M. C. Office for Greenville County in Deed Book 234 at page 121, and this conveyance is made pursuant to the power and authority conferred upon the said Trustee under the terms of that deed.
