containing Seventeen (17) acres, more or less, and being all of tract No. 4 on a plat of the W. M. Sudduth property prepared by W. P. Morrow, Surveyor, dated September, 1942, lying on both sides of the surface-treated road leading from Greer to Highland, and having the following courses and distances, to-wit: Beginning on a stone, corner of Fowler land and the northwestern corner of tract herein conveyed, and runs thence with line of tract No. 5 S. 81 E. 14.60 chains, crossing the Greer-Highland road, to a stake on branch; thence down the meanders of said branch as the line S. 10 1/2 E. 3.57 chains to a stake; thence continuing with said branch S. 10 W. 1.59 chains, S. 24 1/2 W. 1.50 chains, S. 19 3/4 W. .65 chains, S. 1 1/2 W. 1.07 chains, and S. 9 1/2 E. 1.78 chains to a stake, corner of tract No. 3; thence with line of tract No. 3 N. 89 W. 15.00 chains to a stake on line of Fowler land; thence with line of Fowler land N. 4.30 E. 12.75 chains to the beginning corner.
