All that certain piece, parcel or lot of land situate, lying and being on the North side of Sirrine Drive near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as the front part of Lot No. 12 on plat of L. A. Mills property, made by R. E. Dalton, March 1925, and recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book J at page 29 and having according to said plat the following metes and bounds to-wit:-

Beginning at an iron pin on the North side of Sirrine Drive, at the corner of Lots 12 and 13, said pin being 200 feet West from the Northwest corner of the intersection of Sirrine Drive and Ridge Drive and running thence along the rear line of lots 13, 14 and 15, N. 25-28 W. 170 feet to an iron pin; thence across Lot No. 12 S. 64-32 W. 77.1 feet to an iron pin in joint line of Lots 11 and 12; thence S. 25-28 E. 170.8 feet to an iron pin on the North side of Sirrine Drive; thence with the North side of Sirrine Drive N. 64-32 E. 77.1 feet to the beginning corner.

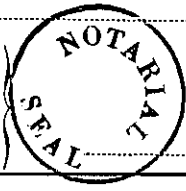
