DEED

KNOW ALL MEN BY THESE PRESENTS, that SALUDA LAND & LUMBER COMPANY, a corporation organized and existing under the Laws of the State of Delaware, GRANTOR, for and in consideration of the sum of One Thousand Two Hundred Eighty Dollars (\$1,280.00) to it paid, at and before the sealing and delivery of these Presents, the receipt whereof is hereby acknowledged, has GRANTED, BARGAINED, SCLD AND RELEASED, and by these Presents does hereby GRANT, BARGAIN, SELL and RELEASE unto R. E. BENSON of Greenville County, State of South Carolina, GRANTEE, that certain boundary of land lying on waters of Middle Saluda River, waters of Gap Creek and Fall Creek, near River Falls, in Cleveland Township, Greenville County, State of South Carolina, composed of two (2) tracts, described as:

- 1. That certain tract of land formerly known as the C. G. Drake land, containing 5.2 acres, more or less, shown on a plat prepared by Howard Wiswall, C. E., Survey of 1918-1920, as "#8 of D-5", reference to which plat is hereby craved for an accurate and complete description thereof, and;
- 2. That certain tract of land formerly known as the E. F. Reynolds land, containing 138 acres, more or less, conveyed by the said E. F. Reynolds to C. G. Drake by deed dated May 17, 1904, recorded in the R. M. C. Office for Greenville County, State of South Carolina, in Vol. LLL of Deeds at page 653, and by the said C. G. Drake conveyed to W. H. E., as "Reynolds", reference to which plat is hereby craved for an accurate and complete description thereof.
