All that certain lot of land situate in the City of Greenville, County and State aforesaid, and being more particularly described as follows: Beginning at an iron pin on the west side of Boyce Street corner of other property of Hattie Parker, thence along said property S. 70-27 W. 58 feet to a stake; thence along line of Camperdown Mills property S. 82-38 E. 44.2 feet to an iron pipe on the west side of Boyce Street; thence along the west side of Boyce Street N. 23-35 E. 27.4 feet to the begining corner.

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining. TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the grantee hereinaabove named, and her heirs and assigns forever.

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee hereinaabove named, and her heirs and assigns, against itself and its successors, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
