G. Davis, of Pinellas County, State of Florida, receipt whereof is hereby acknowledged, have granted, bargained, sold, released and by these presents do grant, bargain, sell and release unto said H. G. Davis, his heirs and assigns forever, the following property, to-wit:

said lot having a frontage of 119.7 feet, a rear width of intersection feet, and a depth of <sup>135</sup>136 feet on one line and <sup>157</sup>135 feet on the other, as will more fully appear from the said plat, reference being hereby made to the record thereof for a more particular description of the lot herewith conveyed.

TOGETHER with the right of enjoyment of privileges and facilities afforded by Lake Lanier, an artificial water, as projected on said plat, for lawful aquatic sports, boating, bathing, swimming and fishing; and together with the further right to erect for the use of the owner of the above described lot a boat house and wharf or landing at some appropriate location on the margin of the said Lake, the said location and the size, plans and specifications of said boat house and wharf or landing to be subject to approval of the TRYON DEVELOPEMENT COMPANY; but nothing herein contained shall privilege a nuisance or license the pollution of the said Lake, its inlets, outlets, or beaches, nor authorize any unlawful, offensive or boisterous conduct, or the use of the said Lake by any person inexperienced in swimming; it being expressly stipulated that the said Tryon Development Company, its shareholders or successors, shall not be liable to any lot owner or any other person for any damage or injury sustained in the exercise of the said privileges and facilities, or by reason hereof.

TOGETHER with all and singular the rights, members, privileges, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the premises before mentioned unto the said H. G. Davis, his heirs and assigns.

This conveyance is made subject to the conditions, restrictions, exceptions, reservations, covenants and reversions, contained in that certain deed of record, dated August 26, 1925, filed September 10th, 1925 and recorded in Volume 119, page 102, in the office of the Register Mesne Conveyances, for Greenville County, State of South Carolina, and reference is hereby made to same, for better particulars pertaining to said property hereby conveyed.
