near the headwaters of Vaughn's Creek, containing 44⁶⁴ acres, more or less, and described as follows:

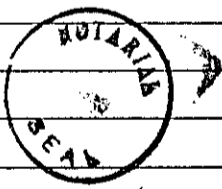
