

TITLE TO REAL ESTATE

STATE OF SOUTH CAROLINA,

WHEREAS heretofore I, J. W. Norwood, of the County and State aforesaid, did on May 1, 1931, cause to be set aside and transferred to myself as trustee for the children of my grandson, Wilkins Norwood, a certain fund to be held upon certain trusts which, however, were not then committed to writing but were thereafter set forth in a Declaration of Trust, probated May 14, 1940, and subsequently in accordance with terms of said Declaration of Trust, I appointed George Norwood as trustee in my place and stead, and

WHEREAS, I desire to amend said Declaration of Trust by providing what disposition shall be made of the trust fund in the event there is a failure of the beneficiaries named in said Declaration of Trust.

NOW, THEREFORE, I, J. W. Norwood as Donor and the creator of said trust, do hereby declare that said trust shall be amended by adding the following provisions which shall be incorporated at the end of page 2 of the original declaration hereto attached:-

"Provided, however, in the event no child of Wilkins Norwood shall live to reach the age of 21 or in the event of the death of Wilkins Norwood leaving no child or children him surviving, the trust estate shall be distributed to the child or children of Lillian Sloan Norwood in the same manner as herein provided for the children of Wilkins Norwood, and

"In the event no child of Lillian Sloan Norwood shall live to reach 21 years of age or in the event of the death of Lillian Sloan Norwood leaving no child or children her surviving, the trust estate shall be distributed to the child or children of John W. Norwood, Jr. in the same manner as herein provided for the children of Wilkins Norwood, and

"In the event no child of John W. Norwood, Jr. shall live to reach 21 years of age or in the event of the death of John W. Norwood, Jr. leaving no child or children him surviving, the trust estate shall be distributed to the child or children of Ben King Norwood in the same manner as herein provided for the children of Wilkins Norwood, and

"In the event no child of Ben King Norwood shall live to reach 21 years of age or in the event of the death of Ben King Norwood leaving no child or children him surviving, the trust estate shall be distributed to the child or children of Oliver Norwood in the same manner as herein provided for the children of Wilkins Norwood, and

"In the event no child or Oliver Norwood shall live to reach 21 years of age or in the event of the death of Oliver Norwood leaving no child or children him surviving, the trust estate shall be distributed to the child or children of Frances Norwood Funderburk in the same manner as herein provided for the children of Wilkins Norwood, and

"In the event no child of Frances Norwood Funderburk shall live to reach 21 years of age or in the event of the death of Frances Norwood Funderburk leaving no child or children her surviving, the trust estate shall be distributed to those answering the description of heirs at law of Frances Norwood Funderburk at the time of her death."

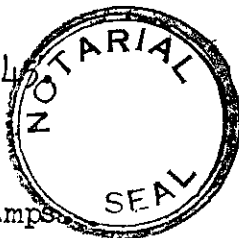
