SEPARATION AGREEMENT (TRIPLICATE)

WHEREAS Private Walter Anderson, of Greenville County, South Carolina, U. S. A., now serving in the Armed Forces of his Country, Overseas, Serial Number 34-846-696, was married to Ollie Mae Goldsmith (now Anderson), of Greenville County, South Carolina, U. S. A., in said County and State on the 18th day of October, 1942.

AND WHEREAS, the said Private Walter Anderson and the said Ollie Mae Anderson, because of certain disagreements and differences, found it impossible to live together as husband and wife and lived separate and apart from each other for sometime prior to his induction into the Armed forces of his Country.

AND WHEREAS, the said Ollie Mae Anderson admits and acknowledges that she has since violated her marital relationship,

Now, KNOW ALL MEN BY THESE PRESENTS, That for and in consideration of the premises hereinabove expressed and the mutual agreement hereinafter expressed, we, the said Private Walter Anderson and Ollie Mae Anderson, hereby agree to live apart and to continue to live apart and separate from each other as husband and wife.

That said Ollie Mae Anderson agrees to release said Private Walter Anderson from any and all marital obligations and from any and all marital obligations incident to the said marriage relationship; she agrees to support herself without any aid or assistance of any kind from said Private Walter Anderson, and agrees not to trouble, disturb or molest him in any way on account thereof; she also agrees to relinquish and release any and all claims and interests to which she may legally be, or to which she might legally become entitled, in, of and to any and all property and property rights now owned or that may hereafter be acquired by said Private Walter Anderson, including the renunciation of Dower and Dower rights, in, of and to any and all real property now owned or that may hereafter be acquired by him, if, when and as she may be so required to do by him; and she also agrees to relinquish and release any and all claims and interests in and to any Government allotments, as well as to any and all funds and moneys, by whatsoever name designated, payable, to be paid or to which said Private Walter Anderson may hereafter become entitled by reason of his service in the Armed Forces of his Country.

That said Private Walter Anderson agrees to release the said Ollie Mae Anderson from any and all marital obligations and from any and all obligations incident to the said marital relationship; he agrees not to require of her any service whatsoever, and agrees not to trouble, disturb or molest her in any way on account thereof; he also agrees to relinquish and release any and all claims and interests to which he may legally be, or to which he might legally become entitled, in, of and to any and all her earnings and in, of and to any and all property and property rights now owned or that may hereafter be acquired by the said Ollie Mae Anderson.

That said parties do, each, now and hereby renounce, release and forever surrender and relinquish any and all other claims either may now have or hereafter have, as against the other, in so far as same may legally be done, excepting the right to obtain a legal divorce without the State of South Carolina at any time hereafter, which right is reserved to both parties hereto, alike.
