All that piece, parcel or lot of land in Chick Springs Township, Greenville County, State of South Carolina.

lying junt north from the Village of Needmore, a settlement of colored people, near the City of Greer, situate on the west side of Spring Street, being all of lots Nos. 12 and 13 on a plat of land made for the Dobson Lumber Company by H. S. Brockman, Surveyor, dated October 28, 1944, and having the following courses and distances: BEGINNING on a stake on the west side of Spring Street, the common corner with lot No. 11, and runs thence with the line of lot No. 11 N. 80 W. 150.2 feet to a stake, common corner of lots 4, 5, 11 and 12; thence with the back line of lot No. 4 and 5 100 feet S. 8.32 W. to a stake, corner of lot No. 14; thence with the line of lot No. 14 S. 80 E. 146.4 feet to a stake on the west side of Spring Street; thence with the west side of said street N. 10.08 E. 100 feet to the beginning corner.
