in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release, unto the said Beattie B. Balentine, his heirs and assigns, all that piece, parcel or lot of land in Greenville Township, Greenville County, State of South Carolina.

about three miles from the Court House, being known and designated as lots 11, 12, 13, 14, 15 and 16 of Sunset Hills according to a plat thereof made by R. E. Dalton, dated December, 1945, and according to said plat having the following metes and bounds, to-wit:

BEGINNING at an iron pin on Osceola (Sunset) Drive at corner formerly of Earle, now Balentine, and running thence with Sunset Drive S. 29-00 E. 185.5 feet to an iron pin, thence around a bend in road 29.5 feet, more or less, to an iron pin in the side of road; thence still with road N. 76-44 E. 75.1 feet to an iron pin; thence still with road N. 76-35 E. 99.8 feet to an iron pin; thence still with road N. 71-53 E. 312.7 feet to an iron pin; thence N. 41-10 W. 254 feet to an iron pin at the corner of property formerly of Earle, now Balentine; thence S. 68-38 W. along the line of said property 448.3 feet to the beginning corner.
