to it in hand duly paid at and before the sealing and delivery of these presents by the grantee hereinafter named (the receipt whereof is hereby acknowledged) has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto

John G. Hammond and Mable B. Hammond, their heirs and assigns:

All that lot of land situate, lying and being on the east side of Maco Terrace, Greenville County, South Carolina, being known and designated as lot No. 8 of property of Central Realty Corporation according to a plat of said property made by Pickell & Pickell, Engineers, March 13, 1946, recorded in the R. M. C. Office for said Greenville County in Plat Book P, page 7, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at a stake on the east side of said Maco Terrace, joint corner of lots Nos. 8 and 9 of said property, and running thence with the line of said Maco Terrace, N. 36-05 W. 55 feet to a point, joint corner of Lots Nos. 7 and 8; thence along the joint line of said lots Nos. 7 and 8, N. 54-03 E. 125 feet; thence S. 36-05 E. 55 feet to a point, joint rear corner of Lots Nos. 8 and 9; thence along the joint line of said lots Nos. 8 and 9, S. 54-03 W. 125 feet to the point of beginning, joint corner of lots Nos. 8 and 9 on Maco Terrace.
