Virgil L. Gustason and Selma G. Gustason, their heirs and assigns:

All that certain lot of land situate, lying and being in Greenville County, South Carolina, on the West side of Maco Terrace, known and designated as lot No. 28-A of property of Central Realty Corporation, according to a plat of said property made by Pickell & Pickell, Engineers, dated March 13, 1946, revised May 31, 1946, and recorded in the R. M. C. Office for said Greenville County in Plat Book P at page 51, having according to the said plat the following metes and bounds, to-wit:

TOGETHER with, all and singular, the rights, members, hereditaments and appurtenances to the said premises belonging or in anywise incident or appertaining.

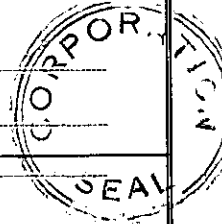
TO HAVE AND TO HOLD, all and singular, the premises before mentioned unto the grantee and hereinafter named, and their heirs and assigns forever.
