All that certain piece, parcel or lot of land situate, lying and being in Greenville Township, Greenville County, State aforesaid, and being Lots Nos. 3 and 4 of the property of L. W. Morgan according to plat made by W. J. Riddle, Surveyor, August, 1946 and more particularly described as follows:

BEGINNING at an iron pin on the West side of Linton Street, joint corner of Lots 2 and 3, and running along the line of Lot No. 2 N. 75-05 W. 148-4 ft. to an iron pin at the rear joint corner of lots 2 and 3 and the property of the Woodside Cotton Mill Co.; thence along the line of the Woodside Cotton Mill Co. property N. 10-41 E. 100 feet to an iron pin at joint rear corner of lots 4 and 5; thence along the line of Lot No. 5 S. 75-06 E. 148.4 feet to an iron pin on Linton Street; thence along Linton Street S. 10-41 W. 100 feet to an iron pin joint corner of Lots Nos. 2 and 3, the beginning corner, and being a part of the property conveyed to the grantor herein by R.
