M. C. Office for Greenville County in Plat Book P at page 127, and having, according to said plat, the following metes and bounds, to-wit.

BEGINNING at an iron pin on the northern side of Bradley Boulevard at the joint front corner of Lot Nos. 92 and 93 and running thence with the line of said lots N. 37-34 W. 182.5 feet to an iron pin at joint rear corner of lot Nos. 92, 93, 121 and 122; thence with the rear line of lot Nos. 92 and 122 N. 52-26 E. 75 feet to an iron pin joint rear corner of lot Nos. 91, 92, 122 and 123; thence with the joint line of lot Nos. 91 and 92 S. 37-34 E. 182.5 feet to an iron pin on the northern side of Bradley Boulevard; thence with said street S. 52-26 W. 75 feet to the point of beginning and being Lot No. 92.
