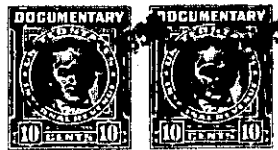

Know All Men by These Presents:

That I, Robert J. Edwards in the State aforesaid, in consideration of the sum of SEVENTEEN HUNDRED & No/100 (\$1700.00) DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Charles V. Hannon, his heirs and assigns:

All those two certain lots of land in Chick Springs Township, Greenville County, State of South Carolina, on the Northwestern side of Mabel Avenue and being shown and designated as lots Nos. 249 and 250 on plat of the property of Robert J. Edwards, made by Dalton & Neeves in May 1951, and when described as a whole have, according to said plat the following metes and bounds, to wit:

BEGINNING at an iron pin on the Northwestern side of Mabel Avenue at the joint corner of lots 250 and 251, and running thence with the line of lot 251 N. 47 W. 200 feet to iron pin; thence with the rear line of lots Nos. 207 and 208 N. 43-00 E. 200 feet to iron pin, corner of lot 248; thence with the line of lot 248 S. 47 E. 200 feet to iron pin on Mabel Avenue; thence with the Northwestern side of Mabel Avenue S. 43 W. 200 feet to iron pin, the point of beginning.

It is understood that this conveyance is made subject to the following restrictions which are expressly made a part of the consideration thereof, and that the same are for the benefit of the grantor, grantee and all other persons owning lots shown on said plat above mentioned.

- (1) Said lots shall be used exclusively for residential purposes.
- (2) No dwelling shall be erected on either of said lots containing less than 1200 square feet of floor space, exclusive of porches.
- (3) No temporary buildings shall be used for residential purposes, nor shall any garage apartments be constructed on either of said lots.
- (4) The outer or exterior walls of any residential dwelling shall be of material other than concrete blocks.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and his Heirs and Assigns forever.

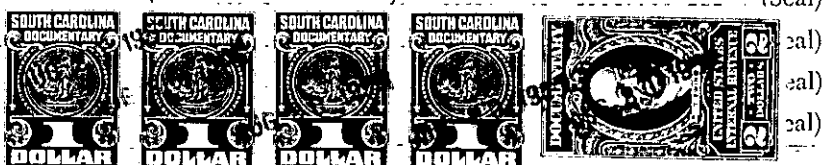
