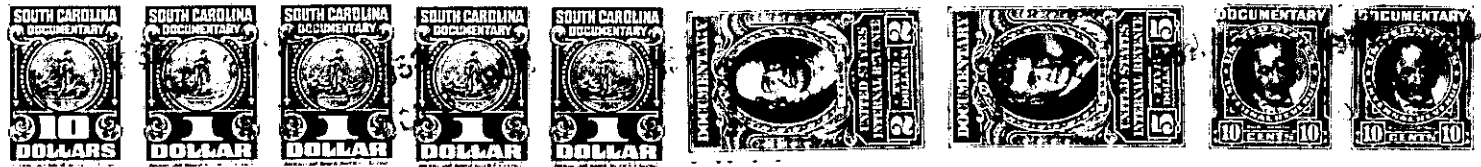
L. E. White and R. E. White their Heirs and Assigns forever:
