

All that piece, parcel and tract of land lying and being in Gantt Town-ship, Greenville County, South Carolina, and being a portion of a larger tract of land conveyed to Luther B. Pinson by C. E. Robinson, as Trustee, by deed dated May 5, 1950, recorded in Deed Book 409, Page 27. It lies on the southern eide of highway number 291 which leads from the Augusta Road to the White Horse Road and is bounded by lands of Davis and Dirton. It begins at corner of lands of J. C. Dirton on the southern edge of State Highway No. 291 and runs thence S. 33-39 E. 65.3 feet to corner; thence along the line of Davis S. 80-32 E. 936 feet to corner; thence N. 27-58 E. 238 feet to center of branch thence along the center of said branch N. 27-14 W. 184.4 feet to corner on the southern edge of State Highway No. 291; thence along the southern edge of said highway S. 81 -33 W. 1001.9 feet to the beginning corner, and containing 5.1 acres, according to survey and plat made by J. Mac Richardson, Reg. Land Surveyor, in May 1954.

Also a 50 foot strip of land lying on the northern side of the property above described to which is intended to include all of the lands adjacent to that here conveyed up to the center of Highway No. 291 subject however to the highway right-of-way.
