to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

A. B. Skelton, his heirs and assigns forever:

All that piece, parcel or lot of land in Gantt Township, Greenville County, State of South Carolina being Lot No. 17 on the east side of Mayflower Avenue in a subdivision known as Pecan Terrace, plat of which is recorded in the R. M. C. Office for Greenville County in Plat Book GG, page 9 and being more particularly described as follows:

BEGINNING at an iron pin on the east side of Mayflower Avenue at the joint front corner of Lots Nos. 16 and 17 and running thence with the joint line of said lots S. 80-48 E. 137.2 feet to an iron pin; thence S. 17-35 W. 171.8 feet to an iron pin corner of Lot No. 18; thence with the line of that Lot N. 38-03 W. 162.8 feet to an iron pin on the east side of Mayflower Avenue; thence with the eastern side of said Avenue along a curve, the chord of which is N. 16 E. 60 feet to the beginning corner.

This lot is conveyed subject to the building restrictions as set forth on the above plat and as recorded in the R. M. C. Office for Greenville County in Deed Book 477, page 291. (Any fuel or oil tank shall be enclosed in the building structure or placed underground).

The above is part of the property conveyed to the Grantor by E. Inman, Master by deed recorded in Deed Book 464, page 392, R. M. C. Office for Greenville County.
