To carry on, assist, or to participate with others, in the organisation, financing (including lending and advancing money,) liquidation, or reorganization of firms, associations, or corporations engaged in any lawful business enterprise, and to land and advance money and give credit to individuals, partnerships, corporations, joint stock associations, and trustees.

- 4. To act as agent or representative of any individual, firm, corporation, syndicate, or association in and about the carrying on of any financial operations of any general business enterprise, and to take such action, either on its own behalf, or jointly with others.
 - 5. To act as adjuster, agents, and br kers in the business of any kind or class of insurance in any or all of its branches, including marine incurance, fire insurance, casualty insurance, workmen's occipensation incurance, fidelity insurance, insurance against loss by defaults, whether willful or otherwise, in the fulfillment of contracts, incurance against loss because of froud, theft, robbe y, of any kind of misconduct, and ront insurance.
- 6. To set as insurance agents and agents for insurance conjunies in coliciting and receiving applications for life, accident health, fire, compalty, plate glass, boiler, elevator, burglary, rent, marine, and credit insurance, and all other kinds of insurance, the collection of premiums, and doing such other business as may be delegated to agents by such companies; to conduct and carry on a general insurance agency and brokerage business, and generally to transact and carry on all kinds of agency businesses.
