All that piece or parcel of land in the City of Greenville, being located between the end of Northwood Avenue and Chick Springs Road and having according to a plat by the City of Greenville Engineering Department the following metes and bounds to wit:

BEGINNING at an iron pin on the North side of Northwood Avenue at the branch, being the present corner between Gibson and Stone; and running thence S 52-30 E 16.5 feet; thence S 40-13 E 11 feet; thence S 1-43 W 22.3 feet; thence S 13-57 W 7.3 feet; thence N 70-38 E 57 feet; thence N 81-31 E 18.4 feet to a point on the western R/W line of Chick Springs Road; thence along said R/W line N 14-29 E 50.4 feet; thence leaving said R/W line N 32-01 W 50.5 feet; thence N 67-56 W 42.3 feet; thence N 56-00 W 11.9 feet to an iron pin at the branch; thence down the branch S 26-00 W 6.7 feet to the point of beginning.
