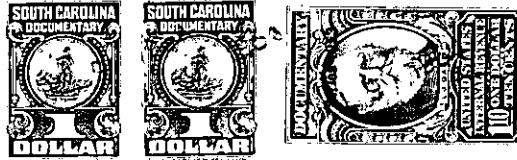
F. C. SLOAK, his heirs and assigns:
