All those lots of land in Greenville County, State of South Carolina, near the City of Greenville, being shown as lots Nos. 2, 3 and 4 on plat of Grove Station Heights, made by Piedmont Engineering Service, May 18, 1948, and described as follows:

BEGINNING at a stake on the Southern side of Moody Street, 151 feet East from a County Road, at corner of lot 5, and running thence with lines of lots 5, 6 and 7, S. 19-06 E. 195 feet to a stake at corner of lot 9; thence with the lines of lots 9 and 1, N. 78-31 E. 185.2 feet to a stake in line of property of Ila Mae Stone; thence with line of said property, N. 18-52 W. 195 feet to a stake on Moody Street; thence with the South side of Moody Street, S. 78-31 W. 186 feet to the beginning corner.
