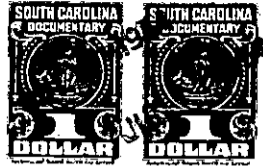

Know All Men by These Presents:

That I, Alfred C. Mann, Jr. in the State aforesaid, in consideration of the sum of Eight Hundred Ninety-Five and No/100-----DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

W. E. McClain, his heirs and assigns forever:

All that piece, parcel or lot of land situate, lying and being in Gantt Township, Greenville County, State of South Carolina on the west side of Mayflower Avenue being Lot No. 63 in a subdivision known as Pecan Terrace, plat of which is recorded in the R. M. C. Office for Greenville County in Plat Book "GG", page 9 and being more particularly described as follows, to-wit:

BEGINNING AT an iron pin on the west side of Mayflower Avenue at the joint front corner of Lots Nos. 62 and 63 and running thence with the joint line of said lots N. 72-27 W. 154.7 feet to an iron pin on rear line of Lot No. 58; thence with the rear line of that lot and Lot No. 57 to an iron pin corner of Lot No. 64; thence with the line of that lot S. 72-27 E. 180 feet to an iron pin on Mayflower Avenue; thence with said Avenue S. 17-33 W. 70 feet to the beginning corner.

This lot is conveyed subject to the building restrictions as set forth on the above plat and as recorded in the R. M. C. Office for Greenville County in Deed Book 477, page 291. (Any fuel or oil tank shall be enclosed in the building structure or placed underground.)

The above is one of the lots conveyed to me by deed recorded in the R. M. C. Office for Greenville County in Deed Book 479, page 532.
