to it in hand duly paid at and before the sealing and delivery of these presents by the grantee(s) hereinafter named, (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto -- HAROLD OGBURN, his heirs and assigns:

All that piece, parcel or lot of land, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 103, Section II, Lake Forest Subdivision, as per plat thereof recorded in R.M.C. Office for Greenville County, South Carolina, in Plat Book EE, page 71, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southwesterly side of Berryhill Road, joint front corner Lots 102 and 103, and running thence S. 53-06 W. 224.5 feet to a point in Brushy Creek; thence with Brushy Creek as the line, the traverse line being N. 27-18 W. 121.8 feet to a point in Brushy Creek, joint rear corner Lots 103 and 104; thence N. 53-09 E. 216.9 feet to an iron pin on the Southwesterly side of Berryhill Road, joint front corner Lots 103 and 104; thence along the Southwesterly side of Berryhill Road S. 36-05 E. 120 feet to an iron pin, the point of beginning.
