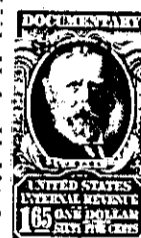
MRS. RUTH M. COOK, her heirs and assigns, forever:

ALL that piece, parcel or lot of land in Gantt Township, Greenville County, State of South Carolina, being known and designated as Lots No. 33 and 34 of a subdivision known as Section "B", of Englewood Estates, as shown by a Plat thereof, dated November, 1951, recorded in the R. M. C. Office for Greenville County in Plat Book, "BB", at Page 11.

BEGINNING at an iron pin on Cherokee Drive at joint front corners of Lots No. 34 and 35 and running thence along the line of said Lot No. 35, S. 87-30 E. 175 feet to an iron pin at back corner of Lot No. 41; thence along the rear lines of said Lot No. 41 and Lot No. 42, N. 2-30 E. 150 feet to an iron pin at back corner of Lot No. 32; thence along the line of said Lot No. 32, N. 87-30 W. 175 feet to an iron pin on Cherokee Drive; thence running with the said Cherokee Drive, S. 2-30 W. 150 feet to an iron pin at point of beginning.

THIS deed is made subject to the following restrictions:

- 1. No house is to be erected costing less than \$5,000.00.
2. No house is to be built closer than 50 feet to the street.
3. No temporary house is to be erected on said lot.



Grantee to pay taxes for the year 1954.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises herebefore mentioned unto the grantee(s) hereinabove named, and her Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
