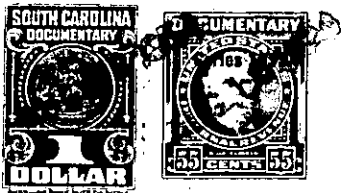

to an iron pin on Dakeland Drive, joint front corner of lots #22
and #40; thence N. 39-28 E. 75 feet to a iron pin, the point of
beginning.

This property is in a restricted district, and is sold subject to the following restrictions, which shall be effective for a period of ten years from the date hereof:

- (1) Said property shall be used as a residence.
- (2) no residence shall be erected hereon at a cost of less than five thousand (\$5,000.00) Dollars.
- (3) no building shall be erected thereon less than thirteen (13) feet of the northern edge of the Dakeland Drive.
