to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said JAMES H. ROLLINS AND MORGAN E. BERRY, THEIR HEIRS AND ASSIGNS,

ALL that certain piece, parcel or lots of land located in Chick Springs Township, Greenville County, State of South Carolina, being shown and designated as Lots No. 10, 11, and 12 of Addition to Pinehurst Subdivision as shown on plat made by W. N. Willis, C. E., dated September 10th, 1949, and having, according to said plat as recorded in the R. M. C. Office for Greenville County South Carolina, in Plat Book "T", at Page 399, the following courses and distances, to-wit:

BEGINNING at an iron pin on South side of Hazel Drive, front corner of Lot No. 10, and running thence S. 29-08 E. 241.5 feet to an iron pin, rear corner of Lot No. 10; thence along rear lines of Lots No. 10, 11 and 12, N. 64-33 E. 180 feet to an iron pin at rear corner of Lot No. 12; thence N. 20-35 W. 142.7 feet to an iron pin on South Side of Hazel Drive, front corner of Lot No. 12; thence along South Side of Hazel Drive, N. 86-50 W. 140 feet to an iron pin, joint front corner of Lots No. 10 and 11; thence continuing with Hazel Drive, N. 85-53 W. 90 feet to the point of beginning.
