

All that certain piece, parcel or lot of land with the buildings and improvements thereon, situate, lying and being on the North side of East Hillcrest Drive, in the City of Greenville, in Greenville County, South Carolina, being shown as Lot 22, Block E, of Property of Lucy L. Hindman, made by Dalton & Neves, Engineers, August 13, 1928, recorded in the R. M. C. Office for Greenville County, S. C. in Plat Book "G", page 208, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the North side of East Hillcrest Drive at a point 415 feet East of North Main Street and running thence with said East Hillcrest Drive S. 66-30 E. 75 feet to corner of Lot 21; thence with the line of Lot 21, N. 23-30 E. 190 feet to an iron pin in rear line of Lot 9; thence along rear line of Lots 9 and 8, N. 66-30 W. 75 feet to the corner of Lot 23; thence with the line of Lot 23, S. 23-30 W. 190 feet to the beginning corner.
