in the State aforesaid, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Maurice Lisagor, his heirs and assigns forever:

All that certain piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, and within the corporatelimits of the City of Greenville, and being known and designated as Lot No. 9, of Section F, of a revision of a portion of the subdivision known as Croftstone Acres according to a plat recorded in the R. M. C. office for Greenville County in Plat Book Y, at page 91, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of Brentwood Drive (formerly known as Mitchell Avenue), joint front corner of Lots 9 and 10, and running thence with the line of said lots, S. 64-46 W. 182.2 feet to an iron pin on the rear line of Lot 19; thence with the rear line of said lot, S. 16-39 E. 75 feet to an iron pin, joint rear corner of Lots 3, 4 and 9; thence with the rear line of Lots 4 and 5, N. 64-34 E. 165 feet to an iron pin on the western side of Brentwood Drive; thence with said drive, N. 4-54 W. 78.6 feet to the beginning corner.

The parties hereto agree that as a part of the consideration for this conveyance the following restrictive covenants apply to the above described property; that said covenants shall run with the land and shall be binding on the parties hereto, their heirs and assigns forever:

- (1) The above described property shall be used for residential purposes only.
- (2) No building shall be erected, placed, or altered on the above described lot until the building plans, specifications, and plot plan showing the location of such building have been approved in writing as to conformity and harmony of external design with existing structures in the subdivision, and as to location of the building with respect to topographyand finished ground elevations by the grantors herein. In the event the grantors herein fail to approve or disapprove such design and location within thirty (30) days after said plans and specifications have been submitted to them, or in any event, if no suit to enjoin the erection of such building or the making of such alterations has been commenced prior to the completion thereof, such approval will not be required and this covenant will be deemed to have been fully complied with.
