unto the said Mrs. Everett Loftis, her heirs and assigns forever:

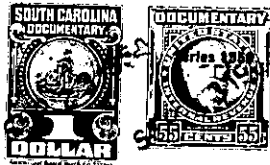
All that piece, parcel or lot of land in Greenville County, State of South Carolina,
