to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said

ANNIE ROLLISON MCGEE, for life:

All that piece, parcel or lot of land, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 6, Property of Florence Rollison, plat of which was prepared in May, 1950, by R. M. Campbell, Surveyor, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southerly side of a proposed driveway at the corner of Lots 5 and 6, and running thence S. 2-30 W. 161.86 feet to an iron pin, joint rear corner Lots 5 and 6; thence S. 87-30 E. 66 feet to an iron pin, joint rear corner Lots 6 and 7; thence N. 2-30 E. 161.85 feet to an iron pin on the Southerly side of the said proposed driveway, joint front corner Lots 6 and 7; thence along the said Southerly side of proposed driveway N. 87-30 W. 66 feet to an iron pin, the point of beginning.
