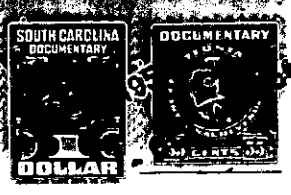


Title to Real Estate by a Corporation

to it in hand duly paid at and before the sealing and delivery of these presents by the grantee(s) hereinafter named, (the receipt whereof is hereby acknowledged), has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto - -

S. W. CREECH, his heirs and assigns:

All that piece, parcel or lot of land, situate, lying and being near the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lot No. 156, Section III, Lake Forest Subdivision, as per plat thereof recorded in the R.L.C. Office for Greenville County, South Carolina, in Plat Book "GG", page 77, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Northerly side of Rockmont Road, joint front corner Lots 155 and 156, and running thence N. 24-23 E. 248.1 feet to a point where the joint line of Lots 155 and 156 intersects the high water line of Lake Fairfield; thence along the high water line of the said lake, the traverse line of which is N. 82-23 W. 253.1 feet to a point where the joint line of Lots 156 and 157 intersects the high water line of the said lake; thence along the joint line of Lots 156 and 157 S. 0-45 W. 203.6 feet to an iron pin on the Northerly side of Rockmont Road; thence along the curve of Rockmont Road, the chord of which is S. 69-40 E. 161 feet to an iron pin, the point of beginning.

The above-described property is conveyed subject to recorded and existing building restrictions, easements, and rights-of-way.

The grantee herein is to pay the 1954 taxes on the above-described property.

Together with all and singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging or in anywise incident or appertaining.

To have and to hold all and singular the premises before mentioned unto the grantee(s) hereinabove named, and his successors, heirs and assigns forever.

And the said granting corporation does hereby bind itself and its successors to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and his successors, heirs and assigns, against itself and its successors, and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
