This conveyance is subject to all easements and rights of way of record.

The Grantees, their heirs and assigns are granted the right to use the Southern Railway - Mills Mill Spur Track stiutate immediately to the rear of the above described premises. In the event of the Aiquidation of the Grantor, or the discontinuance of its business or the use of the spur track, the Grantor will reserve a strip of sufficient width over the resent right of way from the rear of the above premises to the connection of the spur track and the main line. It is understood that service over said spur track is entirely controlled by the Southern Railway Company. In the event the Grantor should discontinue its use of the sour track and the Southern Railway Company, its successors or assigns, shall either remove the rails or refuse to service the foregoing described premises, the Grantor, its successors or assigns, will be released from reserving any strip over said right of way for the use of said property, and in this event the Grantees, their heirs and assigns shall have the option to purchase the abandoned right of way from Deering Street to the Main line of the Southern Railway Company at Guest Street and Green Street for a consideration of One Thousand (\$1000.00) Dollars, said option to be exercised sixty (60) days after the happening of this event.
