Scales, Jr., and L.I. James, their heirs and assigns, an undivided two-fifths (2/5) interest (one-fifth interest to each) in and to, All of that parcel or tract of land in Saluda Township of Greenville County, S.C. lying on the southwest side of U.S. Highway No. 25, about $1\frac{1}{2}$ miles south from the North Carolina-South Carolina boundary line, being a portion of property commonly known as "Chestnut Springs" and shown on plat thereof made by H.L. Dunahoo for D.F.
