P. C. Shuck of the Pickens and Lincoln Service on August 28, 1954 and revised in October of 1954, the following metes and bounds, to-wit:

Lot 17 set a stake in the center of S. J. Highway No. 31 and running thence along the line of Claude Rosamond S. 7-46 E. 477.6 feet to a stake; thence S. 47-04 E. 373.9 feet to a stake; thence S. 79-31 E. 342 feet to a stake; thence S. 24-33 E. 1220.7 feet along the McClellan line in a tree; thence along the line of the old bridge road S. 24-33 E. 37.5 feet to a stake in center of Old Road; thence S. 39-43 E. 477.3 feet to a stake in S. 0. 1 E.
