payable Twenty Thousand Dollars in cash.

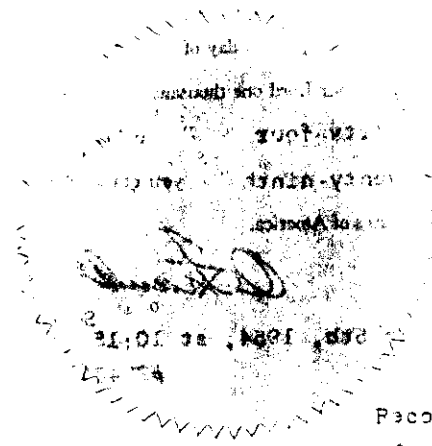
