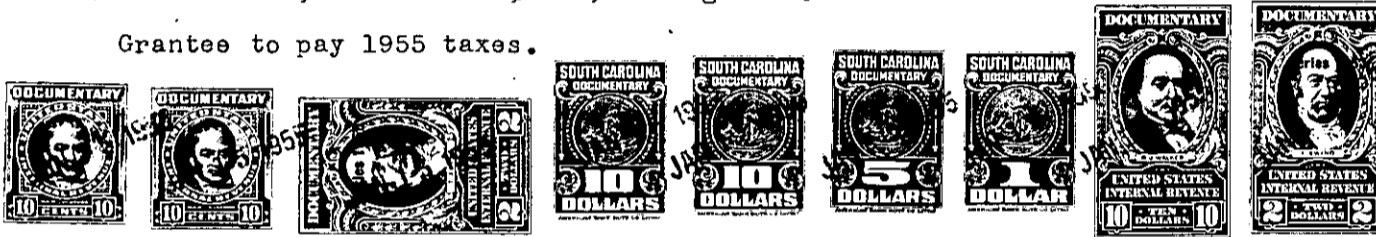
That I, W. M. HUGHES,

ALL that lot of land situate on the North side of Potomac Avenue, in the City of Greenville, in Greenville County, South Carolina, being shown as Lot 166 on plat of Pleasant Valley, made by Dalton & Neves, Engineers, recorded in the R.M.C.
