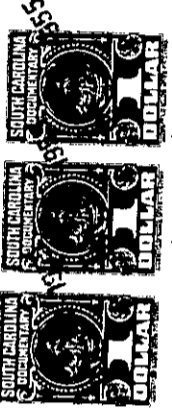
Robert L. Parker, his heirs and assigns, forever:

All that certain piece, parcel or lot of land, with the building and improvements thereon, situate, lying and being on the Southeast side of Phillips Lane in the City of Greenville, County of Greenville, State of South Carolina being shown as Lot No. 17 on Plat of property of John T. Doughs and T. F. Huguenin, revised by Haskell Martin, Architect, November 28, 1946, recorded in the R. M. C. Office for Greenville County, South Carolina in Plat Book "Q", Page 200, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southeast side of Phillips Lane at joint front corner of Lots 16 and 17, said pin being 1370.4 feet in a Southwesterly direction from the point where the Southeast side of Phillips Lane intersects with the Southwest Side of Augusta Road, and running thence with the line of Lot 16 S. 42-30 E. 154 feet to an iron pin; thence S. 47-11 W. 61.7 feet to an iron pin; thence N. 41-30 W. 154 feet to an iron pin on the Southeast side of Phillips Lane; thence along the Southeast side of Phillips Lane, N. 47-11 E. 58.7 feet to the beginning point.

Being the same property conveyed to the grantor herein by Jimmy Nixon by deed recorded in R. M. C. Office for Greenville County, South Carolina, in Volume 512 at page 391.
