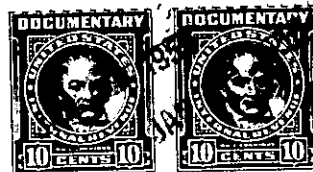

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s), Paul R. Robinson and Barbara P. Robinson, their heirs and assigns forever:

All that certain piece, parcel or lot of land situate, lying and being in the State of South Carolina, County of Greenville, on the southern side of Keith Drive, being known and designated as Lot No. 5 of a subdivision known as Maple Heights as shown on plat thereof recorded in the R. M. C. office for Greenville County in Plat Book HH, at page 49, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Keith Drive, joint front corner of Lots 5 and 6; and running thence with the joint line of said lots, S. 45-05 W. 168 feet to an iron pin at the rear corner of Lot 9; thence with the rear line of Lots Nos. 10 and 12, N. 34-39 W. 76.1 feet to an iron pin, joint rear corner of Lots 4 and 5; thence with the joint line of said lots, N. 45-05 E. 154.2 feet to an iron pin on Keith Drive; thence with said drive, S. 44-55 E. 75 feet to the beginning corner; being a portion of the property conveyed to me by Marshall F. Vaughan by deed recorded in the R. M. C. office for Greenville County in Vol. 503, at page 215.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and their Heirs and Assigns forever.

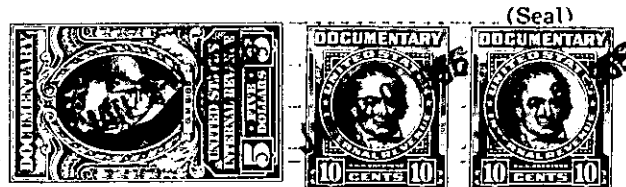
