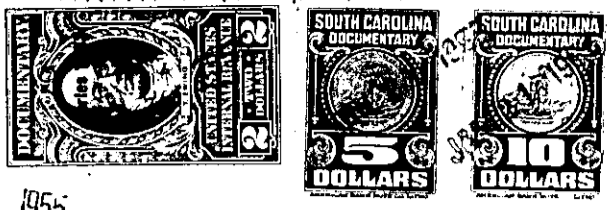

Know All Men by These Presents:

That I, J. P. Medlock, of Greenville County, in consideration of the sum of Eighty-Five Hundred and No/100 - - - (\$8500.00) - - - DOLLARS,

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s), James O. McNabb and Lois L. McNabb, their heirs and assigns forever:

All that certain piece, parcel, or lot of land situate, lying and being in the State of South Carolina, County of Greenville, Butler Township, being known and designated as Lot No. 2 of a subdivision known as Maple Heights, being the property of Marshall F. Vaughan, according to a plat thereof prepared by C. C. Jones, C. E., June, 1954 and recorded in the R. M. C. office for Greenville County in Plat Book HH, at page 49, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwest side of Keith Drive, joint front corner of Lots 2 and 3, which point is approximately 530.3 feet north of the intersection of Keith Drive and Lowndes Hill Road, and running thence with the joint line of Lots 2 and 3, S. 45-05 W. 126.6 feet to an iron pin on the rear line of Lot 14; thence with the rear line of Lots 14 and 15, N. 34-39 W. 85.2 feet to an iron pin at the joint rear corner of Lots 1 and 2; thence with the joint line of said lots, N. 46-50 E. 111.4 feet to an iron pin on the southwest side of Keith Drive; thence with Keith Drive, S. 44-55 E. 80 feet to the beginning corner.

The above described property is a portion of the same conveyed to me by Marshall F. Vaughan by deed dated June 29, 1954 and recorded in the R. M. C. office for Greenville County in Vol. 503, at page 215.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and their Heirs and Assigns forever. And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s') Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s') Heirs and Assigns against the grantor(s) and the grantor's(s') Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof. Witness the grantor's(s') hand and seal this 20th day of January in the year of our Lord One Thousand Nine Hundred and Fifty-Five.
