KNOW ALL MEN BY THESE PRESENTS. That I, J. D. Lindsey

in the State aforesaid, in consideration of the sum of Ten And No/100 (\$10.00) and love and
affection for my daughter and her husband Dollars
to me in hand paid at and before the sealing of these presents
by W. R. Norwood and Virgie Mae Norwood
(the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these
presents do grant, bargain, sell and release unto the said W. R. Norwood and Virgie Mae Norwood,
their Heirs and Assigns forever; reserving a life estate for the Grantor and
his wife, Mary W. Lindsey,

all that piece, parcel or lot of land in Gantt Township, Greenville
County, State of South Carolina, lying and being Northeast of the White Horse Road
and containing 3.63 acres, more or less, and being known and designated as a
portion of Lot No. 9 of the prlperty of W. M. Myers Estate, as shown on a plat
thereof by B. F. Wigington, dated December 12, 1932, recorded in the R. M. C.
Office for Greenville County in Plat Book H, Page 217, and having the following
metes and bounds, to-wit:

BEGINNING at an iron pin at the corner of property now or formerly
belonging to Janie O. Medlin, and running thence S. 55-30 E. 296.5 feet to
an iron pin at the corner of property now or formerly belonging to Granger;
thence S. 84-30 E. 512 feet to an iron pin in the line of property now or
formerly belonging to W. V. Granger; thence along Granger's line N. 3-35 E.
286.4 feet to an iron pin; thence S. 87-30 W. 740 feet to an iron pin at the
corner of property now or formerly belonging to Frances Ellen Myers; thence
S. 34-00 W. 52.5 feet to the beginning corner, and containing 3.63 acres,
more or less.

ALSO, all that strip of land described as follows:

BEGINNING at an iron pin at corner of property of the Grantee herein
and Janie O. Medlin, and running thence along Medlin's line in a Southwesterly
direction 312.7 feet to an iron pin on the Northeastern side of the White
Horse Road; thence along the Northeastern side of the White Horse Road in a
Northwesterly direction 15 feet to an iron pin at the corner of property of
the Grantor; thence along the Grantor's line in a Northeasterly direction
360 feet, more or less to a point in the line of the Grantee's property; thence
along said Grantee's line S. 34-00 W. 15 feet to the beginning corner.

Said strip of land being the same conveyed to me by Frances Ellen
Myers by deed recorded in the R. M. C. Office for Greenville County in Deed
Book 461, Page 258.
