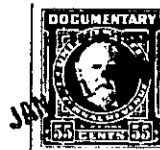

Know All Men by These Presents:

That I, David Dorsey Hulsey,
in the State aforesaid,
in consideration of the sum of One Hundred Seventy Five and No/100 - - - - - DOLLARS,
to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said Helen V. Schumpert, her heirs and assigns, forever:

All that lot of land situate on the East side of Franklin Avenue, in the City of Greenville, in Greenville County, South Carolina, being shown as a portion of Lot 59 on plat of the Rowley Place, recorded in the R. M. C. Office for Greenville County, S. C., in Plat Book "C", at page 5, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the east side of Franklin Avenue, said pin being 180 feet north from the northeast corner of the intersection of Franklin Avenue and Henrietta Street (formerly known as Turpin Avenue) and running thence in an easterly direction 65 feet, more or less, to an iron pin; thence in a northerly direction 60 feet to an iron pin; thence in a Westerly direction 40 feet, more or less, to an iron pin on the east side of Franklin Avenue; thence along the east side of Franklin Avenue in a southerly direction 60 feet to the beginning corner.

This is the same property conveyed to the Grantor herein by deed of M. Dorsey Woodside, dated September 28, 1938, recorded in the R. M. C. Office for Greenville County, S. C., in Deed Book 206, at page 138.

Franklin Avenue referred to above is now known as Primrose Street.

TOGETHER with all and Singular the Rights, Members, Hereditaments and Appurtenances to the said premises belonging, or in anywise incident or appertaining.

TO HAVE AND TO HOLD all and singular the said Premises before mentioned unto the grantee(s) hereinabove named, and her Heirs and Assigns forever.

And the grantor(s) do(es) hereby bind the grantor(s) and the grantor's(s) Heirs, Executors and Administrators to warrant and forever defend all and singular the said premises unto the grantee(s) hereinabove named, and the grantee's(s) Heirs and Assigns against the grantor(s) and the grantor's(s) Heirs and against every person whomsoever lawfully claiming or to claim the same or any part thereof.
