BEGINNING at an iron pin on the Easterly side of Hudson Drive, which iron pin is located 221.6 feet in a Northerly direction from the intersection of Hudson Drive and Butler Springs Road, and is also the joint front corner of Lots Nos. 22 and 23, and running thence along the common line of said Lots S 63-20 E 222.7 feet to an iron pin; thence N 19-0 E 105 feet to an iron pin, joint rear corner of Lots Nos. 23 and 24; thence along the common line of said Lots N 31-30 W 154.3 feet to an iron pin on the Southeasterly side of Greenwood Avenue; thence along the Southeasterly side of Greenwood Avenue S 60-10 W 65 feet to an iron pin; thence continuing along said Avenue S 77-40 W 90 feet to an iron pin at the Easterly corner of the intersection of Hudson Drive and Greenwood Avenue; thence around said corner on an arc, the chord of which is S 47-55 W 35 feet to an iron pin on the Easterly side of Hudson Drive; thence continuing along the Easterly side of said Drive S 16-0 E 60 feet to an iron pin, the point of beginning.
