

to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release

Board of Trustees of School District of Greenville County, No. 520, its successors and assigns forever:

All that tract of land in Tax District 285, Greenville County, South Carolina, containing 12.5 acres, more or less, lying on the North side of U. S. Highway No. 29, and shown on a plat made by Robert Jordan, Registered Surveyor, on November 27, 1954, lying Northwest and inside the City Limits of Greer, South Carolina, and having the following metes and bounds, according to said plat:

BEGINNING at an iron pin at the Southeast intersection of U. S. Highway No. 29 and Jones Road and running thence along U. S. Highway No. 29, N. 67-05 E. 521.8 feet to an iron pin; thence still along said highway, N. 68-45 E. 266 feet to an iron pin; thence S. 8-32 W. 423.7 feet to an iron pin on a poplar; thence S. 30-09 W. 517.6 feet to an iron pin; thence S. 49-17 W. 322.9 feet to an iron pin and a stone; thence N. 66-20 W. 308.7 feet to a bottle cap on a pine stump; thence N. 36-25 W. 232.6 feet to a bottle cap on Jones Road; thence along said road, N. 51-27 E. 341 feet to an iron pin; thence N. 1-28 W., still along Jones Road, 255 feet to an iron pin on U. S. Highway No. 29, the beginning corner.

This property is the remaining portion of 2 tracts conveyed to Ella P. Groce by J. William Peterson, Jr., as Trustee, under the last Will of T. M. Groce, deceased, on July 8, 1939, by deed recorded in the R. M. C. Office for Greenville County, South Carolina, in Deed Vol. 212, at page 111, the said two (2) tracts being therein described as containing 5 acres, more or less, and 22 acres, more or less.
