

Beginning at an iron pin on the southeastern side of Hampton Circle, the front joint corner of lots Nos.-27 and 28, and running thence with the joint line of said lots S. 47-0 E. 187.8 feet to an iron pin; thence S. 36-21 W. 74.2 feet to an iron pin; thence S. 19-41 W. 12.2 feet to an iron pin, corner of lot No. 26; thence with the line of said lot N. 47-0 W. 201.5 feet to an iron pin on the southeastern side of Hampton Circle; thence with the southeastern side of said Street N. 43-0 E. 85 feet to the beginning corner.
