to the grantor(s) in hand paid at and before the sealing of these presents by the grantee(s) (the receipt whereof is hereby acknowledged), have granted, bargained, sold and released, and by these presents do grant, bargain, sell and release unto the said grantee(s), Brent R. Blake and Betty L. Blake, their heirs and assigns forever:

All that certain piece, parcel, or lot of land, with the buildings and improvements thereon, situate, lying and being on the northeast side of Hawthorne Lane (formerly known as Ligon Street), in the City of Greenville, County of Greenville, State of South Carolina, being shown as Lot No. 92 on plat of Langley Heights recorded in the R. M. C. office for Greenville County, S. C. in Plat Book I, pages 142 and 143, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at a stake on the northeast side of Hawthorne Lane (formerly known as Ligon Street), joint front corner of Lots 92 and 93, and running thence with the joint line of said lots, N. 44-23 E. 373 feet to an iron pin on Brushy Creek; thence down and with the meanderings of Brushy Creek, the traverse line being S. 33-15 E., 53.2 feet to an iron pin, rear corner of Lot 91; thence with the line of Lots 91 and 92, S. 44-19 W. 360.3 feet to an iron pin on the northeast side of Hawthorne Lane; thence with said lane, N. 44-87 W. 50 feet to the beginning corner; being the same conveyed to me by J. E. Taylor and Ruth A. Taylor by deed dated November 26, 1951 and recorded in the R. M. C. office for Greenville County in Vol. 446, page 282.

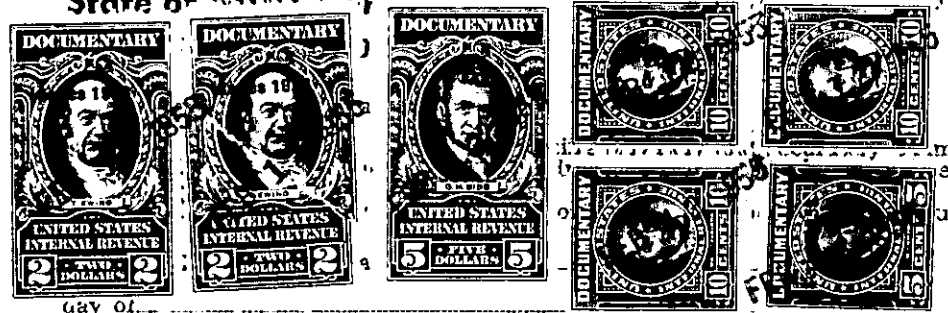
